Dear Generals:

Today is my last day as your NAAG Executive Director. Tomorrow, I start my second retirement, the first being from the United States Army. I look forward to the next phase of my life.

It has been my pleasure and honor to have served NAAG in various roles for the last 18 years. NAAG serves an incredibly important institution – the chief law enforcement and chief legal officers of our 56 jurisdictions. Our paramount goal has always been to help your offices succeed in serving our fellow Americans. When you succeed, consumers are protected from predators, corruption is confronted and defeated, equal rights for all are ensured, and the good administration of government is enabled. Your profession is indeed a noble one.

I have had the privilege to work with an amazing NAAG staff and the countless dedicated public servants who work in your offices. Through their efforts, the past 25 years have seen an explosion of services provided to attorneys general and staff: hundreds of high quality trainings provided at no cost, moot courts and appellate services that have greatly raised the bar of state appellate advocacy, high quality tobacco services that help ensure your jurisdiction gets its full MSA payments, expertise in such areas as consumer protection, antitrust, and public integrity – to name just a few – that frequently assist your offices, and professional conferences and seminars that provide analysis in regards to ongoing and timely issues and concerns for the attorney general community. I could go on, but in the interests of brevity I will stop there.

Most amazingly, as documented in the NAAG Member Value Statements sent to your offices earlier this year, almost every single attorney general office in this country received significantly more value in NAAG services than it paid in dues. That is unparalleled in the association world.

One fact sums up the efforts of your NAAG staff over the years: since 2006 NAAG staff increased by only 13%, but services, as measured by the number and substantive quality of trainings, seminars, and conferences increased by over 1000%.

I have always noticed that acquaintances tell you what you want to hear, but true friends tell you what you need to hear. As your friend, I must tell you things you need to hear, along with some facts that clarify current misconceptions.

NAAG lately has been criticized by a number of attorneys general, with those criticisms being echoed by certain Beltway publications. This leads to a question with a not so obvious answer: what or who is NAAG? In the strictest sense, NAAG is its 56 members. In another sense, NAAG is its leadership: the NAAG Executive Committee. Clearly, in the minds of at least some members, “NAAG” is synonymous with the NAAG staff. Let me address this last view.

Your NAAG staff are from all over the country. There was a time when, like most organizations, NAAG staff all came from the surrounding geographical area. Even before COVID, we changed this model. We now have staff in Texas, Florida,

Arizona, Nebraska, Illinois, New York, Kentucky, and many other locations. This has greatly increased our ability to recruit talented staff.

*NAAG staff do not engage in making policy.* That is strictly the domain of attorneys general. Sign-on letters originate with attorneys general, not NAAG staff. As you may know, by operation of the NAAG constitution, no sign-on letter can commence without at least one Republican and one Democrat co-sponsor, to ensure a modicum of bipartisanship.

*NAAG staff do not select topics for annual meetings or regional conferences.* Topics are selected by attorneys general. In the case of annual meetings this has been done by the NAAG Executive Committee or an Attorney General Meeting Planning Committee. In the case of regional conferences, topics are selected by the regional attorney general chair hosting the conference. Your NAAG staff do their best to advocate for balanced panels and speakers. But in the end, it is not our decision. Sometimes programs lean left, sometimes they lean right, depending on the attorney general or attorneys general in charge. To address this in the future I recommend that the NAAG membership create a bipartisan standing committee of attorneys general that vet and select topics and participants, subject to the initiative topic of the president or regional chair.

There has also been a great number of questions – and misconceptions – about multistate settlements, particularly about set-asides, if any, for NAAG. *NAAG is never a litigant in any multistate proceeding and NAAG staff do not participate in negotiating settlements.* When a multistate is conceived, the practice has been (not determined by NAAG) for participating states to choose an executive committee of states (not to be confused with the NAAG Executive Committee) to lead the investigation and litigation. States that have robust consumer protection divisions and/or have a particularly strong interest in the case are typically chosen by peer states to be on the executive committee. The multistate executive committee then works with all participating states to develop a settlement. As every attorney general is a completely sovereign actor, it is completely up to that AG whether they want to join the settlement. If any attorney general does not like any of the terms, that AG can say “no” and craft their own settlement. In short, any multistate essentially is a group of sovereign actors who need not concede any of their authority to any other participant.

I hesitate to address the *McKinsey* case again, but it continues to be held up as an example of what is wrong with multistates and NAAG. To be completely clear, NAAG “received” \$15 million in no more sense than your bank “receives” your paycheck when deposited. About half of the \$15 million repaid a grant from one of NAAG’s investigative funds. The other half of the \$15 million was used to set up a repository of opioid related documents. Note that these investigative funds were approved and established by the NAAG Executive Committee without any recorded dissent from any member. Also note that NAAG publishes fund reports to the membership at the annual meeting in December. They are always available upon request.

In the case of grant repayment, the terms of such grants require repayment if the litigation is successful. Otherwise, the funds would quickly dry up. Further, I understand the grant played a key role in the resolution of the case. As for the document repository, this was the suggestion of the *McKinsey* executive committee and became part of the agreement *to which every participating state agreed.* Any state that objected to the *McKinsey* terms could simply have decided to seek their own resolution with the defendant. That did not occur.

It is very much the case that occasional multistate carve-outs have benefited the NAGTRI Endowment. The NAGTRI Endowment, in conjunction with the Mission Foundation, fund all NAGTRI trainings, as well as moot courts and other services. These funds allow NAAG to provide trainings and other services at no charge to your office or the taxpayers of your state. In fact, because NAAG endeavors to only use the investment income from these funds, these funds will continue to allow NAAG to provide these services at no cost, in perpetuity.

Finally, I wish to address an issue of great concern to me. Both my predecessor Jim McPherson and I deemed protecting the integrity of the institution as the chief role of the NAAG Executive Director. In that spirit, I have become increasingly alarmed at the growing influence of lobbyist and corporate money in the attorney general arena, particularly involving entities that are being investigated and/or sued by AGs. In particular, the Conference of Western Attorneys

General/Attorney General Alliance (CWAG/AGA) seems to exist for no other reason than to provide access by such actors to attorneys general. I certainly believe that all parties in our national dialogue should have a chance to be heard. But the AGA funding model, e.g., a minimum contribution of \$10k to attend their annual meeting, forecloses access to all but the most well-funded persons and groups. There is clearly no functional vetting mechanism for who gains access and who can essentially buy programming at AGA meetings. This places AGs in a very compromising and potentially embarrassing situation. I have attached AGA's private sector recruitment manual to this email. It is a very troubling document and I advise you to carefully review it.

AGA is overwhelmingly dependent on corporate and lobbyist money for its activities. Dues only account for a very small share of its revenue. That means when you go on a delegation, some lobbyist or corporation is paying for that. When you have your room and airfare paid for, some portion of that is coming from someone you are investigating or suing.

While RAGA and DAGA are required to publicly list their contributors, AGA has no such requirement. Accordingly, no transparency exists that allows the public to know who is gaining access to their AG and at what cost. In short, reforms are clearly necessary if the public trust is to be honored.

Thank you for taking the time to read this email. I hope your tenure is a productive and successful one. There is no higher calling than fighting for justice. I wish you all the best in that endeavor.

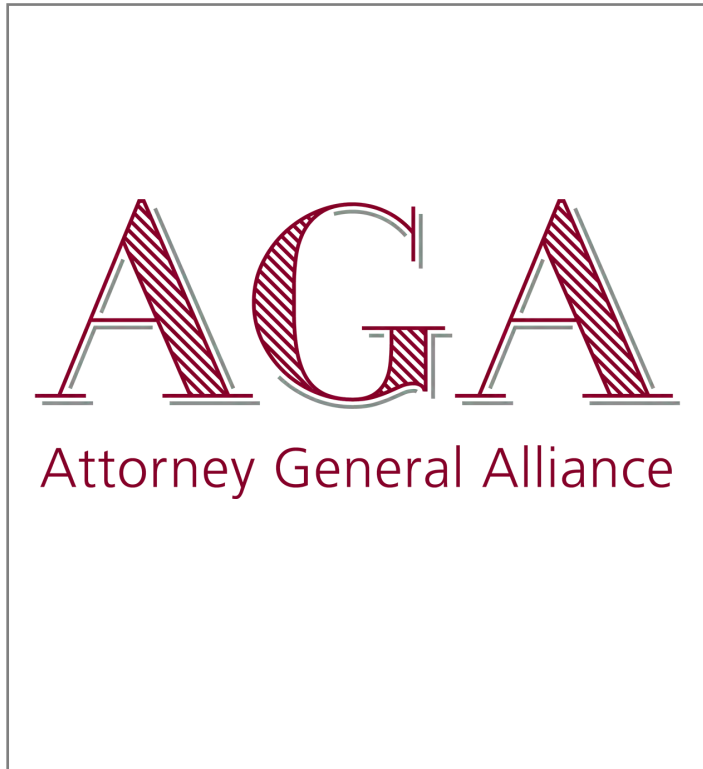

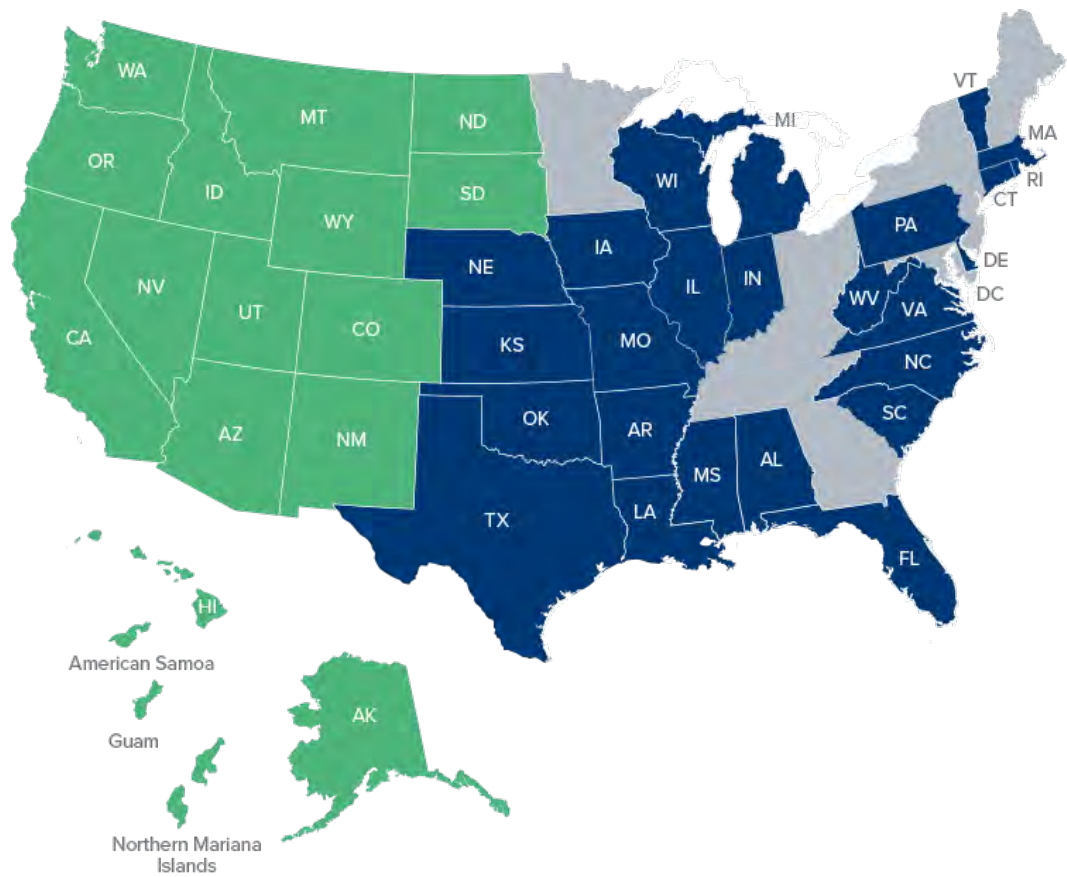

# AGA FORUMS

---

## **TOPICAL MEETINGS**

AGA's leadership strategically selects relevant subjects to be the focus of multiple topical meetings per year. Similar to CWAG's annual meeting, topical meetings bring together AGs, AGO senior staff, representatives from the private sector, academics and other state and federal officials to discuss the most pertinent topics that are of concern to the AGs. Recent topical meetings have focused on Cyber Security and Privacy, Marijuana Legalization, Educational Debt, and Prescription Drug Abuse among others.

## **ANNUAL MEETINGS**

AGA collaborates with AGOs, academics and private sector interests to provide panels which present a variety of views on topics at each annual meeting. This gathering garners participation from across the country, with hundreds of AGO attendees, private sector attendees representing corporations and law firms, and academics and other state and federal officials. The Annual Meeting traditionally hosts over 25 Attorneys General from across the country and up to 850 attendees overall.

## **WEEKLY NEWSLETTER**

AGA publishes the Roundup, which is sent to more than 1,400 members of the AGA community, including state staff, SAGE members and other public and private sector supporters of AGA and CWAG. It serves as a valuable tool to keep members and the interested public informed about the important work our Attorneys General do and the activities of CWAG. The Roundup and accompanying articles are posted on CWAG's website.

## **WEBINARS**

Throughout the year, AGA holds webinars on matters of importance to the Attorneys General. As hosts, AGA includes subject-matter experts from the states, private sector, non-profit and academia to facilitate discussions and exchanges of information.

# AGA PROGRAMS



## **CHAIR'S INITIATIVE: Using Technology to Strengthen Our Economy and Improve the Delivery of Justice**

CWAG-AGA Chair, New Mexico Attorney General Hector Balderas, announces his 2020 CWAG Chair's Initiative, which will focus on using technology to improve social justice. Please mark your calendars and prepare to engage in a dialogue on these important topics!

Building on CWAG's Data Privacy, Anti-Human Trafficking and Consumer Protection efforts, General Balderas' Initiative will feature an in-depth conversation to discuss utilizing technology to strengthen our economy and improve public safety outcomes.

State attorneys general understand the need to implement cyber security programs and protocols. Further, through this effort, impacts on society and often, on those who are most vulnerable, are brought to light as it intersects with public policy, data security and law enforcement actions. Attorneys General also understand the intersection of data privacy and the gig economy, and will spend time discussing the disruptive nature of the latter as it relates to justice.

# AGA PROGRAMS

---

## **CHAIR'S INITIATIVE: Using Technology to Improve Social Justice**

The basis of this initiative will include but not be limited to the following;

**Protecting Children, Families and Consumers:** We will discuss the importance of enhanced enforcement of child online privacy protection laws as well as the use of technologies, like biometric facial recognition protocols, that assist law enforcement in combatting criminal activities such as fraud and money laundering. As technology continues to advance, the rise in economic disparity is ever-apparent, in such issues as tax refunds and expedited Medicare/Medicaid payments. Attorney General Balderas will start a broader conversation about appropriate measures to ensure protection for our communities.

**Protecting Personal Data Privacy:** Instances of hacking and data theft have grown exponentially, so this initiative will focus on the effectiveness of state collaboration in data breach notification laws. This conference will discuss how successful strategies for implementation of safeguards against scams and the emerging electronic consumer marketplace can strengthen our individual data protection.

**Protecting Against Human Trafficking:** As we continue the fight against human trafficking, this conference will discuss the creation of a multi-district communications solution that uses secured and encrypted communications for investigators. Attorney General Balderas will largely focus on the utilization of technological tools which enhance and strengthen our ability to conduct investigations and communicate with agents in multiple jurisdictions without fear of having those channels compromised.

## **CYBERSECURITY WORKING GROUP**

With an ever-increasing focus on cybersecurity, state Attorneys General are turning their attention from discussions and dialogue, to action. This form of electronic crime is perceived as an ever-increasing threat to not only consumers and businesses, but toward national security.

This select, invitation-only group is comprised of Attorneys General, senior staff, and internal cybersecurity experts, who have come to the realization that together, states can more effectively address this type of criminal activity. Having the ability to coordinate actions across multistate jurisdictions and in collaboration with private sector experts has the potential to lay a solid foundation for an impactful national cyber crime initiative.

# AGA PROGRAMS

---

## **SPORTS BETTING SUBCOMMITTEE**

In the wake of *Murphy v. NCAA*, states are addressing sports gambling legalization on a state by state basis. Given this dynamic and rapidly changing legal environment, State Attorneys General are being asked to provide review, advice and potential enforcement of legislative sports gambling proposals now and in future sessions. Many Attorneys General are responsible for providing briefings, opinions and drafting assistance to their legislatures regarding the legal obstacles and parameters for sports betting within their state. The AGA Sports Betting Subcommittee was created to support Attorneys General and their staff in these efforts.

## **CANNABIS PROJECT**

This project is to support Attorneys General who are tasked with enforcing state medical and adult-use cannabis laws through collaboration, education and training, and resource sharing. This group produces a bi-monthly newsletter, hosts forums for regulators, seeks information from Congress, public health officials, federal agencies, private sector and other parties interested in the development and regulatory atmosphere around the topic.





# AGA RULE OF LAW PROGRAMS

## **Alliance Partnership**

National and international members of the AG Alliance work together through our Alliance Partnership organization to promote the Rule of Law. The Alliance Partnership's work centers around providing exchanges and legal training to our foreign neighbors in an effort to unite the private and public sector and promote strong societies and economies. As an organization, we work to counter the negative effects of cybercrime, intellectual property violations, corruption, money laundering and labor or other human trafficking.

The AG Alliance Partnership ([www.TheAGAlliance.org/ap](http://www.TheAGAlliance.org/ap)) program is supported by the state Attorneys General's Offices (AGOs) of 42 US states and jurisdictions. The AG Alliance Partnership promotes collaboration among state Attorneys General from participating countries; supports greater efficiency and transparency in criminal, civil and commercial judicial systems; and provides training programs that promote the effective investigation and prosecution of transnational criminal activity.

During the past decade of fostering institutional relationships with state AGOs in Mexico, the AG Alliance Partnership has generated robust support from every state-level jurisdiction in Mexico, as well as the federal AGO. This collaborative partnership, funded by the State Department's Bureau of International Narcotics and Law Enforcement Affairs (INL), encourages successful prosecutions of trans-border crime and enhanced communication and collaboration with our counterparts in Mexico. Activities include programs to combat transnational crime at the state level, regular communications to strengthen information exchanges among involved AGOs, and training and consulting programs to support Mexican AGOs in their transition to an oral, adversarial criminal justice system. AG Alliance Partnership activities in Mexico have reached more than 35,000 members of the legal community.

The AG Africa Alliance Partnership ([www.cwagaap.org](http://www.cwagaap.org)) is the latest addition to our renowned international rule-of-law efforts.

The AG Africa Alliance Partnership seeks to establish and foster robust relationships with justice and law enforcement agencies and officials in Africa to support the rule of law and combat transnational criminal activity. The AGA collaborates with African Ministries of Justice, Attorneys General, Solicitors General and Public Prosecution agencies to share knowledge and experiences in the fight against crimes like human trafficking, corruption, money laundering, cybercrime and other cross border crimes.

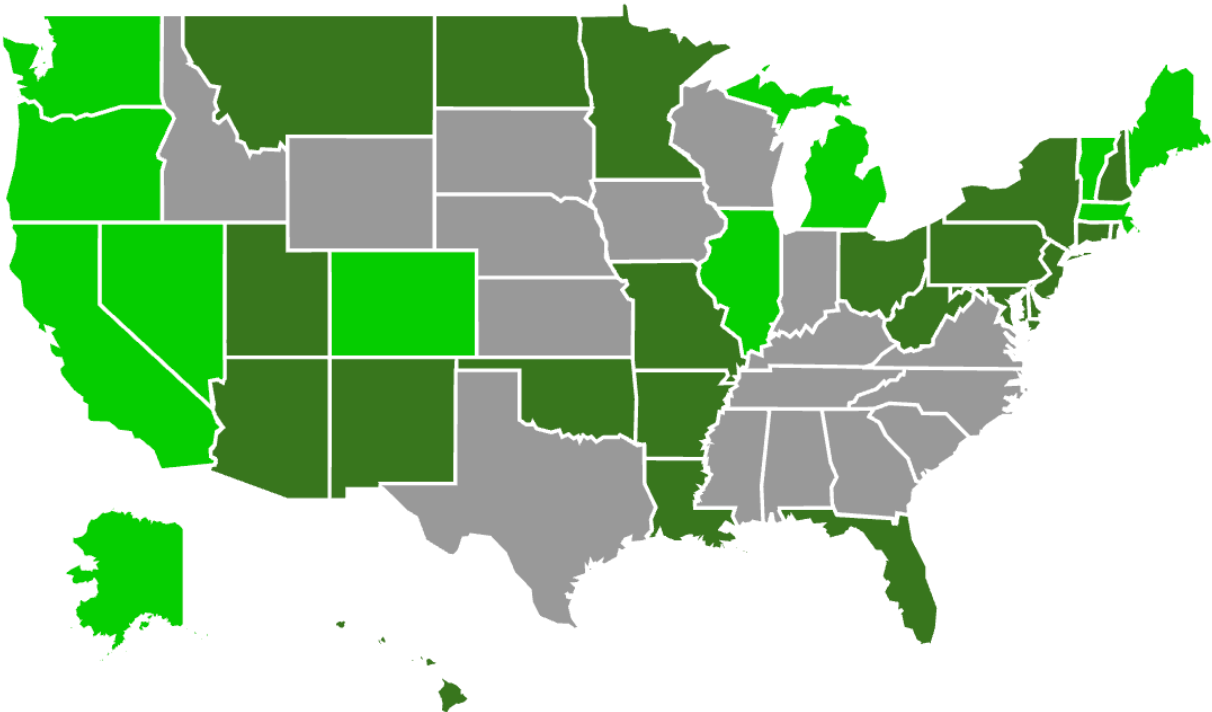

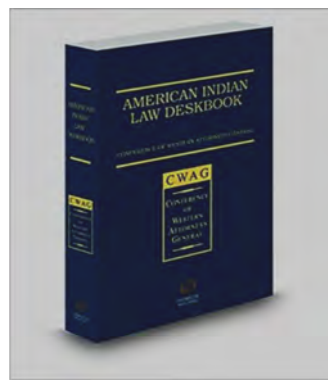

## **AMERICAN INDIAN LAW DESKBOOK**

CWAG has published the American Indian Law Deskbook since 1992, through our partnership with Thomson Reuters. Updated annually, the 2019 Edition is now available. Indian law is a dynamic, ever-evolving field of law. The treatise reflects the current status of Indian law and creates a framework adaptable to new developments, both decisional or statutory. The continuing updates makes it unique among the principal Indian law treatises available over the past 26 years.

The chief legal officers of the States offer a unique insight into Indian law. The States have been parties to many of the cases that have shaped Indian law over the years. It is not unusual for governments, be they federal, state, local or tribal, that share common territories and boundaries to have legal disputes where jurisdiction and authority are the central questions. The purpose of this book is to present a concise, direct and respectful discussion of Indian law, using the most current sources.

In addition to publishing this Indian law treatise, CWAG hosts webinars each year in Indian law. We have presented on the U.S. Supreme Court decision in *Michigan v. Bay Mills Indian Community* and the recent USDOJ policy statement regarding marijuana in Indian country. An upcoming webinar will focus on the Indian Child Welfare Act (ICWA).

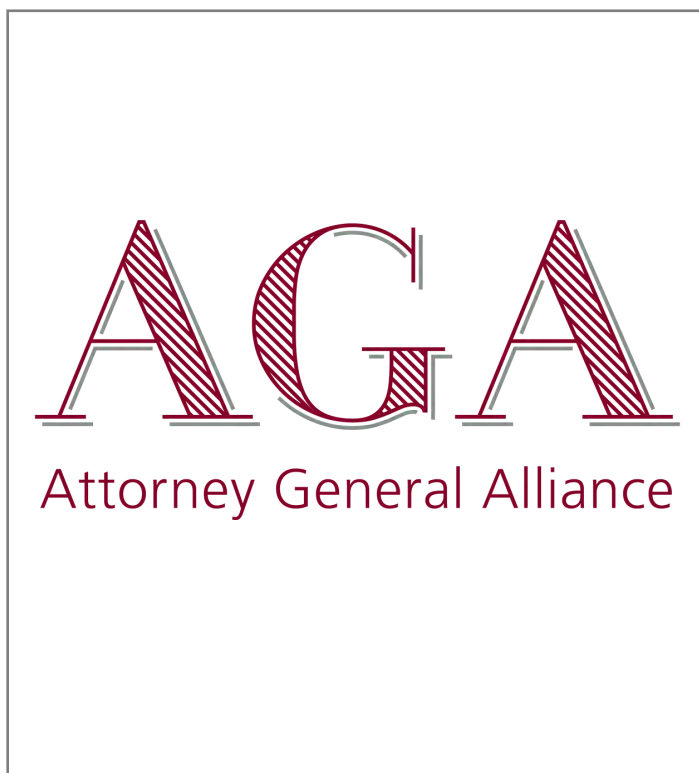
